**BAC AWARDS THE CONTRACT TO COMPUTRENDS SYSTEMS TECHNOLOGY INC.  
FOR THE PROCUREMENT FOR "UPGRADING OF MACHINING AND FABRICATION

**Whereas:**

1. The Bids and Awards Committee posted an invitation to bid for the Procurement of "Upgrading of Machining and Fabrication Facilities" with an approved budget for the contract of Php 621,400.00 on May 16, 2013 at PhilGEPS and other conspicuous place.
2. A pre-bid conference was conducted on May 27, 2013 at 1:30 PM at the Audio-Visual Room, Admin Bldg.
3. The opening of bids was conducted on June 10, 2013 at 1:30 PM, Audio-Visual Room, Admin Bldg. Only one (1) bidder participated in the bidding namely: Computrends Systems Technology Inc. with a bid amount of Php 620,404.00.
4. Based on the abstract of bids, Computrends Systems Technology Inc. was found to be the bidder with the lowest bid.
5. The BAC and TWG conducted a post-qualification evaluation on June 17, 2013.
6. Upon careful verification and deliberation of the bid offers, the BAC through its TWG found that the Computrends Systems Technology Inc. is a sole and responsive bidder for the said project.

**It is hereby resolved:**

1. That the contract for the Procurement "Upgrading of Machining and Fabrication Facilities" shall be awarded to **COMPUTRENDS SYSTEMS TECHNOLOGY INC.** with a bid amount of Php 620,404.00
