CONTRACT AGREEMENT
Procurement of Construction Materials/ Supplies (Consolidated)

KNOWN ALL MEN BY THESE PRESENTS:

THIS CONTRACT made and entered into this AUG 31 2013 2013 at the City of Manila, by and between;

TECHNOLOGICAL UNIVERSITY OF THE PHILIPPINES represented herein by its President, **DR. OLYMPIO V. CAPARAS**, with office address at Ayala Blvd. corner San Marcelino St. Ermita, Manila, and hereinafter referred to as the "TUP";

- and -

UP-TOWN INDUSTRIAL SALES, INC., a business entity duly organized and existing by virtue of the laws of the Republic of the Philippines represented herein by its Manager- Indent & Forward Sales Division, **MS. DAISY M. VILLAFUERTE** with office address at #56 Madison Street, Mandaluyong City and hereinafter referred to as the "Supplier".

WHEREAS, the TUP invited Bids for the **Procurement of Construction Materials/Supplies (Consolidated)** has accepted a Bid by the Supplier for the supply of those goods/services in the sum of **One Million Two Hundred Sixty Four Thousand Twenty Seven Pesos and 65/100 (Php 1,264,027.65)** (hereinafter called "*the Contract Price*").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (a) The Bid Form and the Price Schedules;
 - (b) The Schedule of Requirements;
 - (c) The Technical Specifications;
 - (d) The General Conditions of Contract
 - (e) The Special Conditions
 - (f) The TUP's Notification of Award
 - (g) The Notice to Proceed
3. In consideration of the payments to be made by the TUP to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the TUP to provide the **Procurement of Construction Materials/Supplies (Consolidated)** and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the **Procurement of Materials/Supplies (Consolidated)** and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

5. Supplier shall warrant TUP to provide the **Procurement of Construction Materials/Supplies (Consolidated)** with the following within the warranty period:

- a) Replacement of items within three (3) months if found with poor workmanship/factory defect. However, warranty does not cover abuse, misuse and improper handling & storage of consumables items.

This contract shall take effect upon signing of this **CONTRACT** and issuance of **NOTICE TO PROCEED** unless sooner revoked or terminated for cause.






