PROCUREMENT OF MOTOR VEHICLE (SCHOOL BUS)

The Technological University of the Philippines, through Board of Regent, Utilization of Income CY 2013 per Implementing Order No. 23, S. 2012 dated November 20, 2012; Board of Regent Resolution No. 23s.2012 intends to apply the sum of Php 5,200,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract of Procurement of Motor Vehicle (School Bus). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Technological University of the Philippines now invites bids for the Procurement of Motor Vehicle (School Bus). Delivery of the Goods/Services is required on July 1, 2013. Bidders should have completed, within 30 days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

Interested bidders may obtain further information from Technological University of the Philippines and inspect the Bidding Documents at the address given below during 9:00am - 5:00 pm.

A complete set of Bidding Documents may be purchased by interested Bidders on June 5, 2013 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Php 10,000.00.

The Technological University of the Philippines will hold a Pre-Bid Conference on June 10, 2013 at 9:00 a.m. at the AVR, Admin Bldg. Technological University of the Philippines, which shall be open only to all interested parties who have purchased the Bidding Documents. Bids must be delivered to the address below on or before 9:00 a.m. June 21, 2013. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on June 21, 2013 at 9:00 a.m. at the AVR, Admin Bldg. TUP, Ermita, Manila. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Technological University of the Philippines reserves the right to accept or reject any bid, to amend the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.


