## PROCUREMENT OF LABORATORY EQUIPMENT-CHEMISTRY

The Technological University of the Philippines, through Fund 164 of FY 2013 intends to apply the sum of Php 1,200,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract of Procurement of Laboratory Equipment- Chemistry. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Technological University of the Philippines now invites bids for the Procurement of Laboratory Equipment- Chemistry. Delivery of the Goods/Services is required on May 8, 2013. Bidders should have completed, within 30 days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

Interested bidders may obtain further information from Technological University of the Philippines and inspect the Bidding Documents at the address given below during 9:00am – 5:00 p.m.

A complete set of Bidding Documents may be purchased by interested Bidders on April 12, 2013 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Php 5,000.00.

The Technological University of the Philippines will hold a Pre-Bid Conference on April 16, 2013 at 8:00 a.m. at the AVR, Admin Bldg. Technological University of the Philippines, which shall be open only to all interested parties who have purchased the Bidding Documents.


