

This Memorandum of Agreement made and entered into by and between:

JED DIAGNOSTIC CENTER, a duly organized and existing under and by virtue under and by virtue of the laws of the Republic of the Philippines with office and business address at 350 Arroceros St., 3rd Floor Godino Tower, Ermita, Manila, represented by its Medical Director, **MARIA CECILIA M. CAIGA, M.D.**, and herein referred to as **FIRST PARTY**.

TECHNOLOGICAL UNIVERSITY OF THE PHILIPPINES, a university duly organized and existing under and by virtue of the laws of the Republic of the Philippines with school address at Ayala Blvd., Cor. San Marcelino St., Ermita, Manila, represented by its University President, **DR. OLYMPIO V. CAPARAS** and herein referred to as the **SECOND PARTY**.

NOW THEREFORE, in consideration of the foregoing both parties bind themselves as follows:

JED DIAGNOSTIC CENTER, referred to as **FIRST PARTY** shall:

1. Provide an Onsite Annual Medical Examination services for the incoming First Year students from April 8, 2013 up to June 30, 2013;
 - a. **CHEST X-RAY (11 X 4)** Php 125.00
 - b. **METAMPHETAMINE**
TETRAHYDROXYCANNABINOLS Php 250.00
2. Provide the official result of the student's Chest X-Ray within Twenty four (24) hours.
3. Provide the official result of the student's Drug test within Twenty four (24) hours.
4. Deliver the medical results with full confidentiality personally to the enrollee/applicant who will submit it to the University Clinic.
5. Provide rebates to the University twenty seven (Php 27.00) for Chest X-Ray per student and Fifty (Php 50.00) Pesos for Drug test per student.
6. Provide Mobile X-Ray Van onsite with a back-up unit when necessary.
7. Provide payment direct to the University Cashier office the Electricity Bill for the whole duration.
8. Provide Electrocardiogram and Fasting Blood Sugar testing for free for the faculty and staff of the University.

TECHNOLOGICAL UNIVERSITY OF THE PHILIPPINES, referred to as **SECOND PARTY** shall:

1. Provide a room, rest rooms and other space for the Drug Testing procedure.
2. Instruct all the students that they will pay cash to the Cashier Personnel of **JED DIAGNOSTIC CENTER**.
3. Required the students to present **NOTICE OF ADMISSION** or any **VALID IDENTIFICATION** on the actual medical examination schedule.
4. Require **STUDENTS** to bring 1 piece of 1½ x 1½ picture for Chest X-Ray, Postero-Anterior view

This Memorandum of Agreement shall commence upon signing hereof and will expire on June 30, 2013 unless the same renewed for another year under such terms as may be agreed upon by both parties. However, either party shall have the option to terminate the same with prior written notice of at least Thirty (3) days to the other party.

In consideration of the foregoing, both parties agree further that this agreement shall be treated with strict confidentiality to protect its interests, ensure open communication to enhance business partnership and to work the attainment of drug free and healthy workplace as the primary objectives of this undertaking.
