

CONTRACT FOR PRINTING

KNOW ALL MEN BY THESE PRESENTS:

This contract, entered into this Sep 26 2013 day of 2013, 2013 in Bacolod City, Philippines by and between:

TECHNOLOGICAL UNIVERSITY OF THE PHILIPPINES VISAYAS, a government educational institution existing under the laws of the Republic of the Philippines, with principal office at Talisay City, Negros Occidental, herein after referred to as the "CLIENT", duly represented by its Campus Director, Ma. Leonor F. Validor, Ph.D.

- and -

MAKINAUGALINGON Printer and Bookbinder, a single-proprietorship printing company duly organized and existing under the laws of the Republic of the Philippines, with principal office at 251 Lopez Jaena Street, Baluarte, Molo, Iloilo City, Philippines, herein referred to as "PRINTER", duly represented by its General Manager, Mr. Rosendo G. Mejica.

WITNESSETH:

That the parties hereto agree to abide by the following terms and conditions of this contract to wit:

1. SCOPE AND NATURE OF SERVICE

The printer shall print the following:

1.1 Yearbook 2014 & Box with the following specifications:

- Size: 9 x 12
- Copies: 600 copies
- Cover Material – Kromecote # 130
- Inside Material – C2S # 80
- Flyleaves – C2S # 160
- Ink Colors: Cover – Full color (CMYK)
Inside – 360 pages-Full color (CMYK)
40 pages- One Color (Black)
Flyleaves – Full color (CMYK)
- Inside pages: 400 pages
- Flyleaves: 6 pages
- Finishing – Hard Bound, Back to Back Printing, gold stamping (front only)
- With 30 complimentary copies, the rest same specifications

2. CONTRACT PRICE

2.1 For and in consideration of all obligations and all services rendered by the PRINTER to the CLIENT, the latter shall pay the amount of:

Yearbook 2014 with box – Seven Hundred Seventy Five Thousand Two Hundred Pesos Only. (P 775,200.00)

Mode of Payment:

Thirty percent (30%) to be paid upon submission of materials;
Thirty percent (30%) to be paid upon final layout and approval of client;
Forty percent (40%) to be paid upon full delivery.

3. DELIVERY

- 3.2 The PRINTER is not responsible for any delay due to circumstances beyond its control; however, extension will have to agree by both parties.
- 3.3 The PRINTER shall shoulder the delivery expenses.

4. UNDERTAKING OF THE PRINTER OR CLIENT


- a. Failure of the PRINTER to deliver or of the CLIENT to pay one or more said installments of said TECHNOLOGICAL UNIVERSITY OF THE PHILIPPINES VISAYAS – YEARBOOK 2014 & BOX at times aforesaid; shall not entitle the PRINTER or CLIENT to treat this agreement as repudiated, but the party in default shall be liable to compensate the other for any loss or damage consequent upon such failure.
- b. After the expiration of such 30 days after the delivery, the CLIENT shall be deemed to have accepted all the copies of TECHNOLOGICAL UNIVERSITY OF THE PHILIPPINES VISAYAS – YEARBOOK 2014 & BOX, except such if any, as shall have been rejected the copies with others made in conformity with said specifications.
- c. The CLIENT shall have the right to decide on any and all questions pertaining to the quality and acceptability of the printed TECHNOLOGICAL UNIVERSITY OF THE PHILIPPINES VISAYAS – YEARBOOK 2014 & BOX.
- d. The CLIENT shall regularly review the outputs submitted by the PRINTER per agreed schedule and approve all revisions submitted prior to the final layout.


