BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 2014-13
September 2, 2014

WHEREAS, The Technological University of the Philippines Visayas , re-advertised the Invitation to Bid for the **Supply & Delivery of Electronics Equipment** with reference #2707296 on June 23,2014 and posted the same in conspicuous places namely: Provincial Administration Bldg;Land Bank of the Phils.; Bacolod City Hall and TUPV Bulletin Board on the same date;

WHEREAS, in response to the said advertisements, two(2) contractors submitted letter of intent and apply for eligibility and both were found to be oligible and purchased bid documents;

WHEREAS, two (2) bids were submitted during the opening of bid on July 11, 2014, but only one(1) bidder was rated "passed" the preliminary examination of bids;

WHEREAS, the detailed evaluation of bids conducted resulted in the following:

WHEREAS, only the bid proposals of JVS Audio System for four (4) line items was found to be substantially complying with the specifications of the end user and the bid of Microtech Industrial Inc. was disqualified for not having posted a bid security;

WHEREAS, line item No. 4- Computer Set was taken out from the RFQ because said equipment should have been classified as IT equipment and not electronics equipment.

WHEREAS, the committee had recommended that those items that were not bid considering that it is a line item bid, will be procured through shopping.

WHEREAS, upon post qualification and careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by JVS Audio System, its bid has been found to be responsive;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare JVS Audio System as the Bidder with the LOWEST CALCULATED RESPONSIVE BID for the Supply & Delivery of the following Electronics Equipment:
 - a. 100mhz Digital Oscilloscope
 - b. Variable DC Power Supply 0V-30V 5A
 - c. Digital Trainer
 - d. Professional Amplifier 400 watts
- b) To recommend that items that were not bid considering that it is a line item bid, will be procured through shopping;
- c) To recommend for approval by the Campus Director of the Technological University of the Philippines Visayas the foregoing findings.


