INVITATION TO BID

**CONSTRUCTION OF PERIMETER FENCE FOR 1 HECTARE PORTION OF
THE TUP VISAYAS@SAGAY PROPERTY LOT**

1. The *Technological University of the Philippines Visayas* intends to apply the sum of ONE MILLION FOUR HUNDRED THOUSAND PESOS (PhP 1,400,000.00) being the *Approved Budget for the Contract (ABC) for the Construction of Perimeter Fence for 1 Hectare Portion of the TUPV@Sagay Property Lot*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Technological University of the Philippines Visayas now invites bids for the *Construction of Perimeter Fence for 1 Hectare Portion of the TUPV@Sagay Property Lot*. Completion of the works is required **90 days** after issuance of Notice to Proceed. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a similar project with an amount of at least 50% of the proposed project for bidding. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is open to all interested bidders subject to the conditions for eligibility provided in IRR of R. A. 9184.

4. A complete set of *Bidding Documents* maybe purchased by interested Bidders starting **April 22, 2014** from the address given below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Five Thousand Pesos(PhP 5,000.00) from the BAC Secretariat at the address given below.
5. The Technological University of the Philippines Visayas will hold a *Pre-Bid Conference* on **April 22, 2014- 2:00 p.m.** at *TUPV Conference Room, Capt. Sabi St., Talisay City*, which shall be open only to all interested parties who were declared eligible by the BAC and had purchased the Bidding Documents.
6. Bids must be delivered to the address below on or before May 6, 2014. **All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB of IRR 9184.**

Bid opening shall be on **May 6, 2014 at 2:00 p.m.** at the *TUPV Conference Room, Capt. Sabi St. Talisay City*. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

The Bids and Awards Committee of the Technological University of the Philippines Visayas reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
