**INVITATION TO BID FOR PROCUREMENT OF LABORATORY  
EQUIPMENT FOR THE COLLEGE OF ENGINEERING**

1. The *Technological University of the Philippines*, through the *Fund 101 of FY 2014* intends to apply the sum of *Php 3,500,000.00* being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of Laboratory Equipment for the College of Engineering*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Technological University of the Philippines* now invites bids for the *Procurement of Laboratory Equipment for the College of Engineering*. Delivery of the Goods is required *December 15, 2014*. Bidders should have completed, within *30 days* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
4. Interested bidders may obtain further information from *Technological University of the Philippines* and inspect the Bidding Documents at the address given below during *9:00a.m. – 5:00p.m.*

A complete set of Bidding Documents may be purchased by interested Bidders on *September 4, 2014* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Php 5,000.00*.

5. The *Technological University of the Philippines* will hold a Pre-Bid Conference on *September 12, 2014 at 1:00p.m.* at *BAC Office, 2<sup>nd</sup> Floor Admin Bldg.*, which shall be open to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before *September 26, 2014 at 1:00p.m.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *September 26, 2014 at 1:00p.m.* at the *BAC Office, 2<sup>nd</sup> Floor Admin Bldg. TUP, Ermita, Manila*. Bids will be opened in the presence of the Bidders'

representatives who choose to attend at the address below. Late bids shall not be accepted.

6. The *Technological University of the Philippines* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
