**INVITATION TO BID FOR PROCUREMENT OF LABORATORY  
EQUIPMENT FOR RESEARCH AND DEVELOPMENT  
CENTER (IRTC)**

1. The *Technological University of the Philippines*, through the *Fund 101* intends to apply the sum of *Php 4,460,000.00* being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of Laboratory Equipment for Research and Development Center (IRTC)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Technological University of the Philippines* now invites bids for the *Procurement of Laboratory Equipment for Research and Development Center (IRTC)*. Delivery of the Goods is required *February 27, 2015*. Bidders should have completed, within *2 years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
4. Interested bidders may obtain further information from *Technological University of the Philippines* and inspect the Bidding Documents at the address given below during *9:00a.m. – 5:00p.m.*

A complete set of Bidding Documents may be purchased by interested Bidders on *December 19, 2014* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Php 5,000.00*.

5. The *Technological University of the Philippines* will hold a Pre-Bid Conference on *January 5, 2015 at 1:00 p.m.* at *BAC Office, 2<sup>nd</sup> Floor Admin Bldg.*, which shall be open to all interested parties who have purchased the Bidding Documents.


