**INVITATION TO BID FOR THE PROCUREMENT OF I.T. EQUIPMENT

1. The *Technological University of the Philippines*, through the *CHED Fund* intends to apply the sum of *Php 1,042,556.00* being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of I.T. Equipment Supplies and materials for Network System - CAP*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Technological University of the Philippines* now invites bids for the *Procurement of I.T. Equipment Supplies and materials for Network System - CAP*. Delivery of the Goods is required *30 Days after the issuance of Notice to Proceed*. Bidders should have completed, within *2 years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
4. Interested bidders may obtain further information from *Technological University of the Philippines* and inspect the Bidding Documents at the address given below during *9:00a.m. - 5:00p.m.*

A complete set of Bidding Documents may be purchased by interested Bidders on *January 7, 2015* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Php 5,000.00*.


