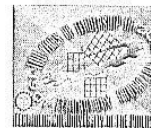

**RESOLUTION**  
**(2014-RESO-001eh)**  
**November 4, 2014**

**BAC DECLARES ANGELS SPORTSWEAR THE SOLE RESPONSIVE BIDDER  
 FOR THE PROCUREMENT OF SPORTS UNIFORM**

**Whereas:**

1. BAC posted an invitation to bid for the Procurement of Sports Uniform (ABC: **Php 1,127,000.00**) on September 8, 2014 and to conduct the Pre-bid Conference on September 19, 2014 from 10:00 - 11:00AM. However it was moved to September 26, 2014 from 2:00-3:00AM due to the suspension of work caused by Typhoon "Mario".
2. The bids were opened on October 10, 2014 from 9:00 to 10:00AM, among the 3 prospective bidders: Gembar, Frontliners and Angels Sportswear who bought the bid documents only Angels Sportswear submitted the bid proposal. Below is the result of evaluation as presented in the abstract of bids:


3. The sole bidder, ANGELS SPORTSWEAR, was subjected to Post-Qualification and it was found out that it is a responsive bidder.
