CONTRACT AGREEMENT
Procurement of College of Science Chemistry Laboratory Equipment (25M)

KNOWN ALL MEN BY THESE PRESENTS:

This CONTRACT made and entered into this ____ day of _____ 2015 at the City of Manila by and between:

TECHNOLOGICAL UNIVERSITY OF THE PHILIPPINES represented herein by its President, **DR. ADORA S. PILI**, with office address at Ayala Blvd. corner San Marcelino St. Ermita, Manila, and hereinafter referred to as the "TUP";

- and -

BROWNSTONE ASIA-TECH, INC., a business entity duly organized and existing by virtue of the laws of the Republic of the Philippines represented herein by its General Manager, **MR. EDGARDO S. BATE** with office address at No. 10-A (Old No. 310) H. Poblador St. Barangay, Hagdan bato Libis, Mandaluyong City and hereinafter referred to as the "Supplier".

WHEREAS, the TUP invited Bids for the **Procurement of College of Science-Chemistry Laboratory Equipment (25M)** has accepted a Bid by the Supplier for the supply of those goods/services in the sum of *Four Hundred Ninety Seven Thousand Two Hundred Sixteen Pesos and 50/100 (Php 497,216.50)*, (hereinafter called "*the Contract Price*").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) The Bid Form and the Price Schedules;
 - (b) The Schedule of Requirements;
 - (c) The Technical Specifications;
 - (d) The General Conditions of Contract
 - (e) The Special Conditions
 - (f) The TUP's Notification of Award
 - (g) The Notice to Proceed
3. In consideration of the payments to be made by the TUP to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the TUP to provide the **Procurement of College of Science – Chemistry Laboratory Equipment (25M)** and to remedy defects therein in conformity in all respects with the provisions of the Contract.

The Entity hereby covenants to pay the Supplier in consideration of the provision of the **Procurement of College of Science – Chemistry Laboratory Equipment (25M)** and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. Supplier shall warrant TUP to provide the **Procurement of College of Science – Chemistry Laboratory Equipment (25M)** within the warranty period of one (1) year from date of delivery; Spare parts are covered with this warranty. During the period, any product found to be faulty will be repaired or replaced free of charge.
6. The delivery date of the equipment shall be thirty days (30) days after receipt of Notice to Proceed by **Brownstone Asia-Tech. Inc.**
7. The TUP hereby covenants to pay the Supplier in consideration of the provision of the **Procurement of College of Science – Chemistry Laboratory Equipment (25M)** and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

This contract shall take effect **upon signing of this CONTRACT and issuance of NOTICE TO PROCEED** unless sooner revoked or terminated for cause.

IN WITNESS whereof the parties hereto have caused this Contract of Agreement for the Procurement of College of Science – Chemistry Laboratory Equipment (25M) to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


