**INVITATION TO BID FOR THE  
PURCHASE OF LIBRARY BOOKS**

1. The *Technological University of the Philippines Manila Campus*, through the **Fiduciary-Library Fund (CY 2018-3 Years Development Plan and Current Income)** intends to apply the sum of Nine Million Sixteen Thousand Two Hundred Pesos (Php 9,016,200.00) for the contract for each lot/item being the Approved Budget for the Contract (ABC) to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *Technological University of the Philippines Manila Campus* now invites bids for the **Purchase of Library Books**. Delivery of the Goods is required **fifteen(15) calendar days after the issuance of Notice to Proceed**. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

In addition, bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or

outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *Technological University of the Philippines Manila Campus* and inspect the Bidding Documents at the address given below during 9:00a.m. to 5:00p.m from Monday to Friday (except on holidays).
5. A complete set of Bidding Documents may be purchased by interested Bidders on **July 31, 2018** from the address below and upon payment of the applicable fee (in the amount listed below) for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **August 28, 2018 at 10:00AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found..**

Bid opening shall be on **August 28, 2018 at 10:00AM** at BAC Office, 2<sup>nd</sup> Floor Admin Bldg. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Bidders must submit a Letter of Intent on or before the submission of their bids to signify their intention to participate in the bidding activity.

The *Technological University of the Philippines Manila Campus* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
